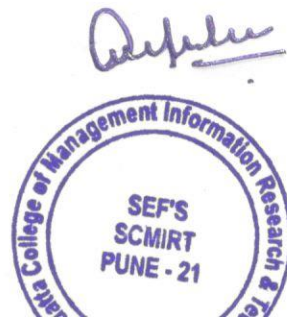

(SCMIRT) AY 2019-20 Report on Session of IPR

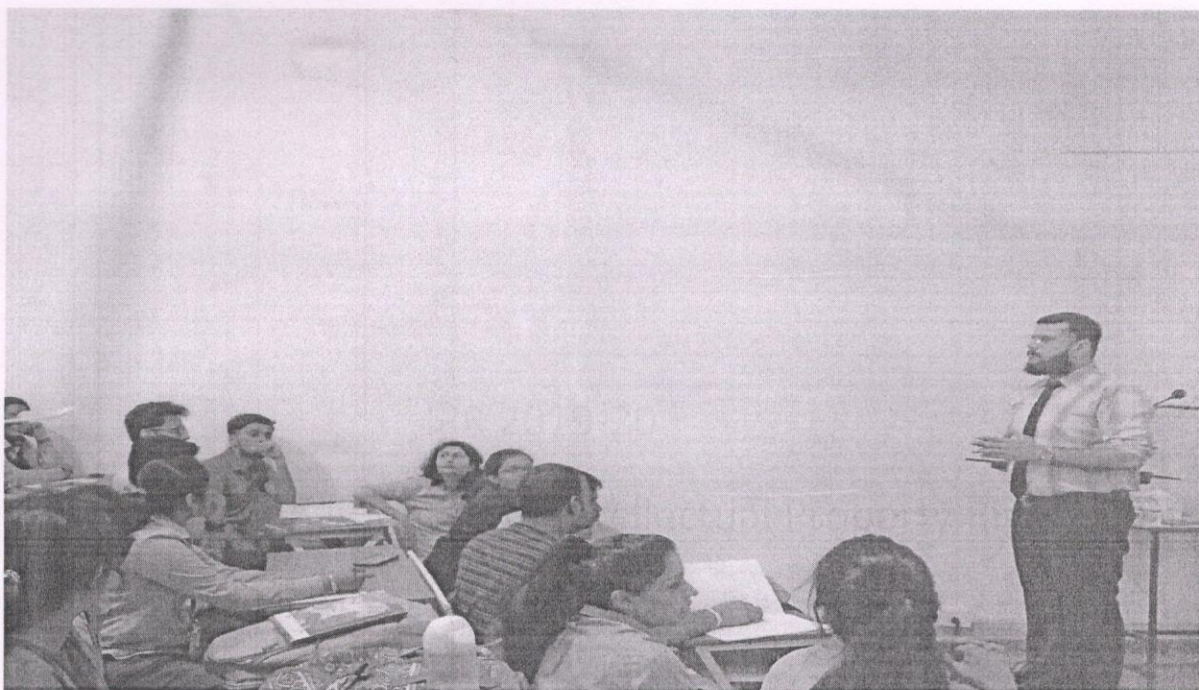
Intellectual Property Rights Encourage Innovation and Reward Entrepreneurs.
