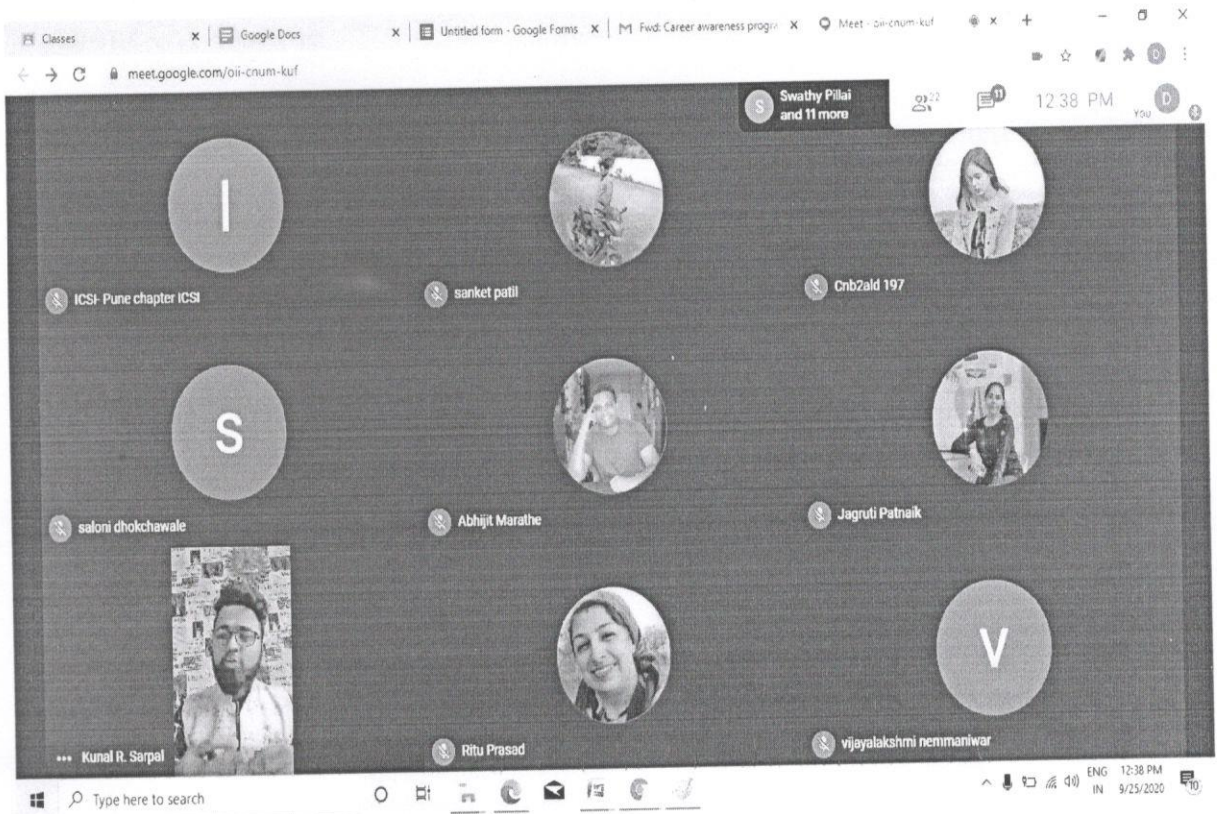


### Welcome Speech:

## About CS Course

1. He said being very average I was able to complete CS course successfully as I found my space, it was interesting and matching with my skills.  
CS course requires lot of readings. More theory part is there. Many law sections need to be by heart. Legal literacy is required here, So your interest in theory, continuous reading capacities i.e at least 7-8 hours reading every day is something very essential while perusing the course.

### **About CA Course**

He insisted that for completing CA Course more analytical approach is expected. More numerical along with theory is part of CA Course. So you need to practice a lot with analytical mind. Questions are very challenging, so students may require 3- 6 years Studies also. Lot of hardwork, patience, focused studies are expected.

### **About CMA Course**

He insisted that along with analytical skill you should be very smart financially. This again requires focused regular studies of 7 to 8 years. Hardwork, patience and researched approach for learning is required. Because portion is huge and challenging.

He concluded that his friend from interior not from English medium was able to complete CS and now he is also a very successful CS Practitioner. Only thing required is your commitment for studies with hard work and focused efforts.

He insisted to join a professional course .E.g. Every year we have to do a certain mandatory hours of learning .it's called professional development hours. In these professional development sessions you meet all companies

criticism i.e. city level then, you made all of them in Maharashtra, then you made all of them in the western region, then in India and then they have an International Convention. So it's a very good bonding that is created among the fraternity members and similarly when you meet people from my profession there is a certain level of knowledge guarantee, certain level of Polish guaranteed and continuous practical application of knowledge also guaranteed because of the training.
