This agreement is made on 4th March 2023 between-

 - b) The Intern will hold the Confidential and Proprietary Information received in the strictest confidence and will not, without the company' prior written consent, copy or disclose to any third party any portion thereof; and
 - c) The Confidential and Proprietary Information of the company will not be copied or reproduced by the Intern without prior written consent of the company.
 - d) All Confidential and Proprietary Information and copies thereof shall remain the property of the company.
 - e) The Intern agrees that, upon termination of the agreement, or at any time upon the request of the company, the Intern will promptly:
 - i. Return or destroy, at the option of the company all originals and copies of all documents and materials containing the company's Confidential and Proprietary Information in possession of the Intern;
 - ii. deliver or destroy, at the option of the company, all originals and copies of all summaries, records, descriptions, modifications, negatives and other documents or materials, whether in writing or in machine-readable form, prepared by it or prepared under its direction or at its request from the documents and materials referred to in subparagraph (a); and
 - iii. provide a written statement to the company, certifying that all documents and materials referred to in subparagraphs (a) and (b) have been delivered to the company or destroyed, as requested by the company.
